

CSR Policy of Camson Bio Technologies Limited

This policy, which encompasses the company's philosophy for delineating its responsibility as a corporate citizen and lays down the guidelines and mechanism for undertaking socially useful programmes for welfare & sustainable development of the community at large, is titled as the 'Camson's CSR Policy'

CSR VISION STATEMENT & OBJECTIVE:

1. Board level CSR Committee

At Camson, our CSR governance structure will be headed by the Board Level CSR committee that will be ultimately responsible for the CSR projects undertaken. The committee will report to our Board of Directors

2. Role of CSR Committee

- Formulate and update our CSR Policy, which will be approved by the Board of Camson
- Suggest areas of intervention to the Board of CAMSON
- Approve projects that are in line with the CSR policy
- Put monitoring mechanisms in place to track the progress of each project
- Recommend the CSR expenditure subject to the provisions of Companies Act, 2013 read together with rules thereunder to the Board for their approval

3. Sound corporate activities

Camson endeavors to comply with regulations, related laws, and internal rules, exercise sound and fair corporate practices, earn the trust of stakeholders such as customers, shareholders, employees, business partners, and society. Camson will not engage in relationships with individuals or groups that threaten social order or safety.

4. Provision of valuable goods and services for society

Camson will provide valuable products and services with superior quality and safety to society, endeavoring to increase the satisfaction and trust of our customers and contributing to the healthy development of society.

5. Respect for human beings

Camson will respect diversity and individual human rights and provide a healthy and safe working environment in which all persons receive fair treatment without discrimination. It will also oppose enforced labor and child labor and respect fundamental human rights as well as workers' rights.

6. Protection of the natural environment

Camson will proactively engage in environmental efforts and work to protect the natural environment, as these are common issues for all mankind.

7. Responsibility to society as a corporate citizen

Camson will carry out corporate activities that take into account the cultures and practices of each country and region and proactively engage in activities that contribute as a good corporate citizen to society.

8. Transparent operating activities

Camson will communicate extensively with customers, shareholders, employees, business partners, and society and disclose business information in a timely and fair manner. It will also conduct reliable financial reporting through accurate accounting processes.

9. Scope of CSR activities in CAMSON

As a practice, we classify those projects that are over and above our normal course of business as CSR. At present, Camson is involved in CSR activities with trust called SARTHI (Sustainable Agricultural Rural Thrust Initiative). SARTHI is engaged in following activities:

1. Training to promote rural sports nationally recognized sports and Olympic sports
2. Rural development projects.
3. Promoting education, including special education and employment enhancing vocation skills
4. Ensuring environmental sustainability, ecological balance, agroforestry, conservation of natural resources and maintaining quality of soil, air and water
5. Measures for reducing inequalities faced by socially and economically backward groups
6. Such other activities as decided by the CSR committee subject to Schedule VII of Companies Act, 2013

This policy applies to all our CSR projects and it will be further reviewed and updated

10. CSR Budget

The total budget for the CSR projects will be decided by the CSR Committee as per the applicable provisions of Companies Act, 2013.

11. Treatment of Surpluses

Any surplus generated from CSR projects undertaken by us will be tracked and channelized into our CSR corpus. These funds will be further used in development of the CSR projects.

12. Responsibility of top management

Top management and employees in managerial positions within each department must understand that they play an essential role in fulfilling the spirit of this Charter and thus, in addition to leading by example, they must ensure that this information is disseminated to everyone and all related parties. Management must always strive to understand the opinions of those both inside and outside of Camson to develop a sound internal framework that ensures that the spirit of this Charter is upheld.
